<b>Bidding time extension:</b>	Bidding time for an item shall be extended automatically by 2 minutes, if a bid is made up to one minute before end of bidding time.

<b>Buyer's premium:</b>	Buyers will be charged a commission on the respective highest bid. The amount may vary depending on the item and project. On the item details page you will find the respective buyer's commission.
<b>Payment:</b>	Amount must be effected to the Surplex bank account by <b>31/07/2023</b> at the latest. <b>Full payment cashed on our bank account is precondition for collection!</b> <b>A cash payment is possible only at the Surplex GmbH office (Düsseldorf, Germany), but not at the loading points.</b>
<b>Billing:</b>	Once the auction closes, SURPLEX will issue the bill to the successful bidder on his behalf.
<b>Security deposit:</b>	Participation in this auction is only possible after depositing a valid credit card. Your credit card will not be charged automatically. No amounts will be blocked after the card data has been deposited. Surplex will NOT charge your credit card during the normal purchase process which includes punctual and complete payment. After placing a winning bid on the auction, you will have the possibility to choose the payment method. In case of late or non-payment Surplex reserves the right to charge the unpaid amount in part or in full from the deposited credit card.
<b>Minimum Prices:</b>	For some lots of the auction minimum prices have been set! Should the minimum prices not have been reached, the seller of these items will be informed about the highest bids after the end of the auction sale. He will then decide whether the lots will be sold for the prices realized. If the seller agrees to sell an item to the highest bidder despite of the fact that the reserve price was not met, the potential buyer will be informed of the decision within two days from the auction's end. Until then, the submitted offer is binding. If a lot should not have met the minimum price yet, this is mentioned in the bidding box.

<b>VAT Portugal:</b>	Reverse charge procedure is applied for buyers from Portugal with a valid VAT ID.
<b>VAT Germany:</b>	Buyers from Germany with a valid VAT ID don't have to pay the VAT to the auctioneer. If no valid VAT ID is provided, the Portuguese VAT has to be paid.
<b>VAT (non-EC customers):</b>	Foreign customers from states that do not belong to the EC receive an invoice including the VAT. This invoice has to be balanced including all fees and VAT. Upon receipt of the duly stamped original export documents (e.g. form no. 3 of the single administrative document) from the last EC-customs office Surplex will reimburse the value added tax to the buyer.
<b>VAT (EC customers):</b>	<b>1.) Collection by forwarder.</b> Intra EC deliveries subject to VAT are made at zero tax. The VAT has to be balanced by the buyer in his own country at its particular conditions on the sum of the purchase. Invoices are sent out net of tax. Upon registration it is essential that the buyer gives his intra-community VAT number, given to him by his tax authority. If this VAT number is not supplied, Surplex reserves the right to add the local VAT to the sum of purchases and fees. <b>2) Self collectors by car or truck</b> (not by forwarder). For tax-free delivery we need the following documents: a) excerpt from the commercial register b) signed and stamped certificate of authority from the general agent to the collecting person (with the content, that the collecting person is allowed to pick up the purchased goods) c) copy of the passport of the collecting person d) acknowledgement of receipt in German language (provided by Surplex) signed by collector Please note that a pick-up without any of the above mentioned terms is not possible. Otherwise we have to charge the full VAT. We are asking for your appreciation.
<b>Origin &amp; Preferences:</b>	Please note that we cannot normally issue certificates of origin and preference documents, such as EUR-1, or declarations of origin on the invoice for the items in the auction, as the previous documents required by law are not available to us. The unauthorized issue and use of preference documents is considered tax evasion or of aiding and abetting tax evasion.
<b>CE Certificate &amp; EU Conformity:</b>	Please note that not all items in this auction come with EU certificates of conformity and CE certificates. In exceptional cases, missing EU certificates of conformity or CE certificates may be requested for individual heavy machines. The costs incurred will be charged to the buyer.
<b>Exclusion of warranty:</b>	All assets are used and will be sold "as is, where is". No warranty or guarantee on any asset!
<b>Customs declarations:</b>	If the Surplex GmbH is the legal exporter as per customs law, all export declarations are to be issued in the name of Surplex GmbH. The issuance of export declarations in the name of Surplex GmbH is done by Surplex GmbH itself only or by an authorized representative which has to be nominated by Surplex itself. The issuance of export declarations in the name of Surplex GmbH by third parties without authorization of Surplex (e.g. customers freight forwarder) is prohibited.
<b>Dismantling/Collection:</b>	<b>Unless otherwise stated, the buyer is responsible for the dismantling, packaging and collection of the purchased items.</b> The collection of purchased items is <b>only</b> possible at the specified collection times.
